





# Vision of Hope Health Alliance (VOHHA)




- 1753 uninsured, low-income adults received eye care and eye glasses/other materials at no cost
  - Interpretation services provided (165)
- 161 made and 121 kept appointments for primary medical care

#### Sherrie 44 yo AA female

• Sitting at her desk wearing her glasses that were glued and taped, lenses scratched Sherrie thought.....







#### Sherrie

- She called the Illinois Eye Institute for an appointment.
- She met with Mary the VOHHA team member. Mary determined she qualified for VOHHA.
- Sherrie was hopeful that this was the break she was looking for to help her start a new life.





#### Sherrie

- "The best experience this year..."
- Referral for general medical care







#### Self-certification

- Meet with VOHHA team prior to exam
  - Low no show rate (3%)
  - Interpretation
- Self reliant
- Transportation to IEI
- 50% no pcp





#### Denise 53 yo Caucasian

- Lost her job due to cutbacks at telephone company
- Became homeless
- Salvation army
- Long time since eye exam





#### Denise 53 yo Caucasian

• Eye care/ eye glasses

Started her own dog walking business

#### Service agency partners

- Most Service agency partners assist
  - Homeless
  - Substance abuse
  - Former prisoners
- Immigrant





#### Service Agencies

- Individually know patients
- Try to assist patients
  - Chinese American Service League (CASL)
  - Teen Challenge International





#### Service Agencies

- Case worker is often making referral for eyecare
- 50% no PCP
- Know about VOHHA through signs, brochures





## Service Agencies

- No show rate 25%
  - Rehabilitation
- Transportation issues





### Richard 35yo H

- Sees Dr. M at Alivio Medical Center
- Speaks limited English
- Doctor recommended eye exam
- Richard doesn't know why
  - Vision fine





### Richard 35yo H

- Limited understanding of VOHHA
- Referral form from Alivio
  - DM





## Richard 35yo H

- Father interprets for Richard
- Glasses RX
- No retinopathy
- Pt ed
- Ocular findings report sent to Dr. M

## Federally Qualified Health Centers (FQHCs)

- FQHC vs. SA FQHC larger
- Referral often made by physicians
- 98% PCP
  - 50% HTN, DM





## Federally Qualified Health Centers (FQHCs)

- No show 33%
  - Trust, familiarity with program
- Transportation issues
- 17% interpretation





## All partner agencies important


- People referred to VOHHA reflect partner agencies.
