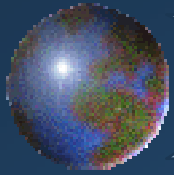




Regional Context

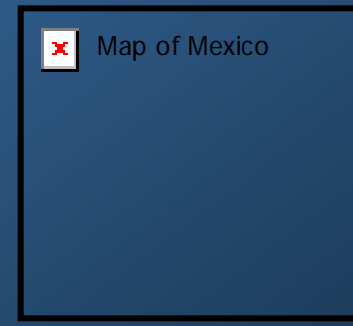
- Limited EC knowledge & access
- Conservative policy frameworks
- Gender-based violence & inequality
- Strong religious influence
- Unwanted pregnancy
- Unsafe abortion
- Maternal mortality

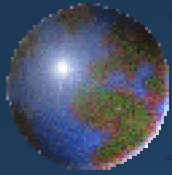




National Contexts

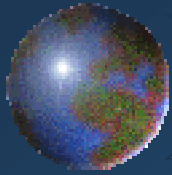
- Belize – Women not using contraception: 53%
- El Salvador – Abortion status: total ban & penalization
- Guatemala – Total fertility rate: 4.4
- Honduras – Teen pregnancy rate: 49%
- Mexico – Abortion rate: 20% reported
- Nicaragua – Unmet need for family planning: 15%





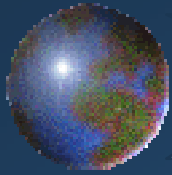
National EC Status

Country	Legalized	Availability
México	2004	Widely Available – FP clinics, pharmacies
Honduras	1999	Available – FP clinics, pharmacies
El Salvador	1999	Available – Providers, pharmacies
Guatemala	2007	Limited – Few FP clinics, some hospitals
Nicaragua	1997	Limited – Few providers, some pharmacies
Belize	–	Very Limited – Few pharmacies & FP clinics



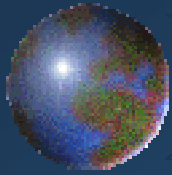

 - ❖ Guatemala – CDH (Center for Human Development)

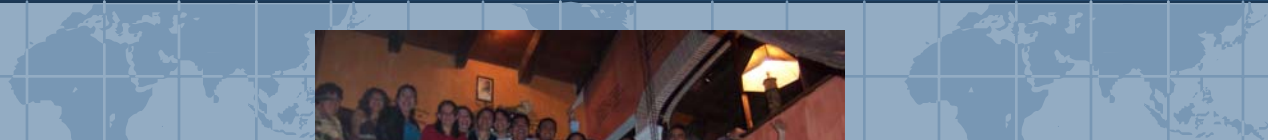
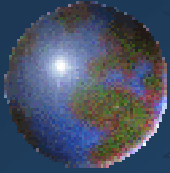




Lessons Learned
