








 - Coal-fired power plants
- Heavy metal contamination of Cheyenne River
 - Run off from Black Hills mines
- Loss and contamination of tribal lands, relocation of tribal communites
 - Oahe dam flooding
 - Armstrong gunnery range



- Land use practices











- Development of an Environmental Health Advisory Committee
- Future research
 - Cherry Creek residents
 - Specifically requested more information on level of exposure to metals
 - Tissue analysis
 - Hair
- Developing a research protocol
 - Based on follow-up concerns by community members and clinicians
 - Autoimmune disease (known to be linked to heavy metal exposure)
 - Status of immune system
 - Pilot to be funded by Center for Clinical and Translational Science Center at UNM
- Research team will begin working with Tribal Council of approval and input on research goals and design
