

Inspections became customary

  Need a clear description of what we do in EH
  Nationally
  Build consistency
  Build capacity
  - Build accountability

#### Where We Need to Be

- Essential Public Health Services
  Essential Services of Environmental Health
  NPHPS
- National Environmental Public Health Performance Standards project
- What about environmental health?

#### The Problem

The extent to which the NPHPS assess the capacity of local environmental public health programs to perform the Essential Environmental Health Services has not been evaluated

## The Questions

- Is there an association between the NPHPS and an accepted set of Environmental Public Health Performance Standards?
- What is the significance and predictability of the association?

# Scope


Develop a set of performance standards and instrument for EnvPH

- 10 standards
- 55 indicators
- 60 questions

Apply instrument in the 56 counties that completed the NPHPS in 2002

Compare results from EnvPHPS to results from the NPHPS


Frequency of Level of Meeting the Environmental Public Health Performance Standards (EnvPHPS) for Counties Completing the EnvPHPS Instrument

# **Key Findings**

- The capacity to provide the EssEnvPHS was limited
- The capacity to provide the EssEnvPHS was generally higher than the capacity to perform the EssPHS
- There was weak correlation between the EnvPHPS and the NPHPS

# **Key Findings**

The NPHPS do not adequately assess the capacity of LEHPs to perform the EssEnvPHS Several barriers were identified as influencing the outcome of the EnvPHPS scores There was a lack of formal public health training among field staff The field staff is relatively young with limited experience

#### Recommendations

- The EnvPHPS should be adopted as a method for measuring the capacity to perform the EssEnvPHS
- Train staff on the performance standards and best practices

Complete a gap analysis then write and implement action plans aimed at enhancing the capacity to perform the EssEnvPHS

#### Recommendations

- Use the EnvPHPS developed for this research as a starting point for the development of national standards
- Conduct research to determine the effectiveness of the EnvPHPS in reducing or preventing illness

### Value

Provides a clear sense of purpose to the work
Elevates the perception of us to a complete and comprehensive public health program
Can assist with budget justification
Can be applied to a system or specific program
Orient new and existing staff
