Developing our new Kane Kares Nurse Family Partnership Program in Kane County challenged us....

#### Nurse Family Partnership

- **First-time, low-income mothers**
- Pregnancy through child's 2<sup>nd</sup> birthday
  - Nurses have three goals:
  - 1. Improve outcomes of pregnancy
  - 2. Improve child health and development
  - 3. Improve family economic self-sufficiency

# Major Program Outcomes

Improved prenatal health Reduction in child abuse & neglect Reduction in childhood injury Increase in father involvement Increased intervals between births Increased maternal employment Improved school readiness Reduction in crime

### **Cost-Benefit Analyses**

- NFP, when implemented with fidelity to the model, produces significant benefits for children and their parents, and over time will return \$2.88-\$5.70 for every dollar invested
- Costs are recovered by child age four and cost savings continue to build throughout the lives of both mother and child
- Savings accrue to government from:
  - Decreased spending on child protection, health care, education, criminal justice, mental health and public assistance
  - Increased taxes paid by employed parents

# Kane County (NFP Data, 2007)



- 539 clients served since program inception in 2001
- Median income of clients is \$17,500
- 89% are receiving Medicaid
- 92.6% are unmarried
- Median age is 17

#### Ethnicity/race of clients:

13.6% non-Hispanic white, 71.1% Hispanic, 12.2% African-American, 2.7% multi-racial, .4% Asian

# Kane County (NFP Data, 2007)



- 52.5% enrolled by 16 weeks of pregnancy (42% Nationally)
- 77% initiate breastfeeding exceeding the NFP goal of 75%
- 56% decrease in domestic violence reports after enrollment
- Statistically significant reductions in tobacco use

# Illinois Plan for Local Assessment of Need (IPLAN)

- Community-driven process for assessing need and choosing priorities
- Child abuse and neglect selected for priority
- Local county board funding issue for juvenile offenders



# Kane County Profile (IPLAN, 2006)

- 40 miles west of Chicago and 520 square miles
- Eastern urban corridor of county follows river, western rural area
- Contains 2<sup>nd</sup> and 8th largest cities in Illinois
- 493,735 estimated population, 2006
- 79% Caucasian, 6% African American, 27% Hispanic (largest percentage of Hispanics in an Illinois county)
- Median Income, \$53,000
- 8,000 births annually, (40-45% covered by Medicaid)






# MCH IPLAN Problem Map




#### System of Case Management and Home Visitation

#### Kane Kares Nurse Family Partnership (KK NFP) Assures Medical Home/Access to Primary Care

- KK NFP Nurses support and facilitate family linkage and relationship-building with:
- Prenatal care provider
- Primary Care Provider
- Specialty Care Provider as needed
- Oral care provider
- Mental Health provider as needed
- Pediatric provider
- EI care manager if needed
- Developmental screening, evaluation, and early intervention referral and coordination

KK NFP Nurse gives VOICE to client barriers, needs, gaps at the planning and policy tables for system level development

# KKNFP Assures Services for Social /Emotional Health

- Screening for maternal depression prenatal, postpartum, postneonatal
- Social-emotional screening for infant
- Domestic violence screening
- Referral, Linkage, Support for diagnosed mental illness and for diagnostic evaluation
- Referral, Linkage, Support for abnormal screenings
- Supporting mother and family members in ongoing issues related to social-emotional health
- KK NFP nurses participated in ABCD Project and Domestic Violence SPRANS Grant for system level development and partnership with primary care providers

# KK NFP Assures Early Care and Education

- Helps assess options for child care and preschool
- Assists with child care subsidy application and child care choice that is high quality
- Offers referral and linkage to Early Head Start, Parents as Teachers, and other parent support programs/systems
- Completes NCAST, parenting screening, parent teaching with focus on ongoing anticipatory (and real time) education on developmental ages and stages, speech, language, and reading
- Assists parents to understand resources for child to transition to 3-5 service system (as needed)

# **KK NFP Assures Family Support**

- Early parenting support even before birth—by 16 weeks on average
- Assesses and partners with the entire family system, including the father and his family
- Helps mom to assess her entire support system to explore ways to maximize personal and social support
- Helps mom to build relationship with primary care providers
- Breastfeeding Support before and after birth
- Resource Referrals and Linkages for social network and social capital development
- Life course development with coaching on self-sufficiency issues
- Environmental assessment and intervention for family

# KK NFP Assures Parenting Education

- Helps mom to identify her "heart's desire" for herself and her baby
- With the mom, explores her experience of parenting and helps her develop her own vision and values for her parenting role, goals, strategies
- Objective screening and assessment of mother-baby bonding and ongoing effective intervention and support
- Life course development, including educational goals for parents
- Child abuse and child safety screening, assessment, education and monitoring


# KK NFP Addresses System Gaps in Kane County

- We have limited services that address the social and behavioral determinants of perinatal health
- Not just parenting education, but also parenting support and role development
- Not just intervention such as smoking cessation or stress reduction classes, but also addressing environmental and psychosocial stressors
- Not just screening for domestic violence, but also individualized support, safety plan development, and coordination of services

# **KK NFP Intensive Intervention**

- By 16 weeks gestation
- Sixty four visits by second birthday
- Multiple domains—personal health, maternal role, environmental health, life course development
- Holistic family-based approach
- Mutual goal setting and evaluation
  - Offer basic Family case management, Teen Parent Services, High Risk infant Follow up, maternal and child screening, referral, linkage, and coordination

Community needs assessment and outcome data must drive the integration of programs into the Early Childhood System


Introduction of a new program asset can create tension in the existing system and this must be addressed directly

**Recognition of efforts and results and mutual support is the "energizer" bunny for partnerships** 


