Virginia Tech Shooting (2007)

Worst single act of gun violence in American history

- 32 murdered
- 15 wounded
- 1 suicide

One of many school shootings in the U.S. in past 20 years

Amish School (2006) 5 murdered 6 wounded 1 suicide

Red Lake, MN (2005) 10 killed 7 wounded

Arizona School of Nursing (2002)

3 professors killed

1 suicide

> 80 die

>900 criminal gun uses many gun intimidations Why does US have so many more school shootings and other mass deaths than other developed countries?

Who Currently Has Guns at College?

% of Students with Guns at College Yes (4.3%)

Binge Drink & Drive	12.0%**
Smoke	6.1%**
Cocaine	9.0%**

Miller et al. J Am College Health 2002

Puts others at risk % students victimized by gun at college Yes (1.6%)

In regions with more guns, more college students have guns

Where more college guns, more college students victimized/threatened with guns.

Miller et al. J Am College Health 2002

Prevention:

After 1996 massacre in Tasmania, Australia massive mandatory gun buyback

18 years before intervention, 13 mass shootings11 years after intervention, 0 mass shootings

Plus major falls in firearm homicide, firearm suicide

non-firearm homicide, non-firearm suicide unchanged

Chapman et al. Injury Prevention 2006

Virginia Tech Massacre

In no other developed country could the shooter have obtained his firearms so easily

e.g. Canada:

 handgun magazine restricted to 10 rounds or less
 handgun acquisition requires proof of legitimate purpose (e.g. bona fide collector)
 requires firearm LICENSE To obtain License:

- criminal background check
- training certificate
- 2 references (who sign application)
- 28 day waiting period

Non-Governmental Action Also Can Help:

In some US college towns with waiting periods, when local student asks for permit, sheriff contact university to check if any problem

Keep guns away from drunk students depressed students...



Means Matter Campaign

Encourage mental health professionals to recommend making guns less accessible to at-risk youth.

Help reduce overall suicides and homicide-suicides (e.g. school shootings).
