

RHInterchange: Creating a Community of Practice for Improved RH Supplies Management

What Is the RHInterchange?

Developed in 2003, the RHInterchange (RHI) is a web-based tool of the Reproductive Health Supplies Coalition that collects order and shipment information from the central procurement departments of UNFPA, USAID and IPPF. It provides the detail of each order for each country and program (an example is on the reverse). The RHI captures \$100 million annually of contraceptive shipment information going to over 55 countries around the world. The focus of phase one of the project (2003 – 2005) was twofold: (1) ensuring donors were aware of the value of contributing information, and (2) harmonizing donor data.

Now in its second phase (2007 – 2009), the RHI is charged with engaging country-based managers to help expand the information to include procurements conducted in-country, as well as forecast data. Over the next months, with feedback from key stakeholders in-country, we hope further adaptations of the tool will allow in-country managers to make more informed and coordinated decisions.

As a result, improved dialogue between and among all concerned managers and donors will help to achieve improved commodity security, better donor harmonization with government-led priorities, and ultimately, country ownership.

Who Is the RHInterchange For?

In a 2005 study, Mercer Consulting identified four issues which restrict contraceptive commodity availability, including "Donor funding allocation and procurement activities are inefficient[; and] Country planning and procurement is fragmented and slow." The RHI addresses these issues by providing better data on orders, shipments and needs, and improving channels of communication between and among supply managers, procurement agents and donors.

By providing concrete, accurate, and easy to access data - specifically on commodity needs and orders - the RHI can be a valuable tool for a variety of users including:

- Country program managers: RHI can provide access to consolidated information on inbound supplies; RHI information can be used to inform logistics decisions and contraceptive security committees
- Advocacy groups: RHI can inform discussion points regarding donor funding patterns; reviewing the rational allocation of resources
- Researchers: RHI information can support policy papers on long-term method use and areas for improvement
- Private sector (manufacturers): The RHI can help manufacturers gain insight into the larger donor market
- Headquarters-based donors: RHI information supports discussions on countries at risk of supply disruptions. Countries-At-Risk meetings are held on a monthly basis and attended by donor agencies which provide or fund RH supplies. Regular attendees include UNFPA, USAID, the World Bank and KfW.
