Background

 Induced abortion is important from health, political, religious and rights perspectives

 Accurate information on abortion can inform policies and the public discourse

Definitions

• Safe abortions

(a) Abortions in countries where the law is not restrictive and

(b) those that meet legal requirements in countries where the law is restrictive

Unsafe abortions

 Abortions done by people lacking the necessary skills or in an environment that does not conform to minimum medical standards, or both

Definitions (2)

• Unsafe abortions, operational definition:

(a) Abortions in countries where the law is restrictive and


(b) those that do not meet legal requirements in countries where the law is not restrictive

Data sources


- Safe abortion:
 - Official statistics, national surveys, experts
- Unsafe abortion:
 - Hospital-based studies, community surveys, qualitative research
- Trends:
 - 1995 estimates using comparable methods (Henshaw, Singh and Haas, 1999)

There were almost 42 million abortions in 2003, down from 46 million in 1995


Millions of abortions




The decline in the abortion rate is primarily in developed countries



Abortions declined dramatically in Europe




The biggest decline was in Eastern Europe




The abortion rate in the US is higher than in Northern and Western Europe




Almost half of all abortions are unsafe



Most abortions occur in Asia



More than a third of all pregnancies are unintended, and one in five ends in abortion



Summary

- There were about 42 million abortions, or 29 abortions for every 1,000 women 15-44, in 2003
- Most abortions occur in developing countries
- The abortion rate is comparable across regions
- The abortion rate has decreased most dramatically in Eastern Europe


Discussion points

 Level of abortion is not linked to legal status of abortion

 Other research has shown a strong link between abortion levels and prevalence of contraceptive use

Abortion declined as contraceptive use increased in the Russian Federation

Percentage change since 1988




Discussion points

 Other research also shows an association between the legal status and safety of abortion


Almost all abortion-related deaths occur in developing countries

Deaths per 100,000 unsafe abortions, 2003



The incidence of abortion deaths in South Africa declined by 91% after change in law

Policy implications

 Improved access to contraceptive services can decrease the incidence of abortion

 Making all abortions safe can reduce maternal mortality
