Executive Summary

Chapter 171 of the Laws of 2007 requires the President of the Civil Service Commission to prepare an annual report describing occupational injuries, illnesses and workers' compensation experience incurred by classified employees in Executive Branch state agencies. The annual report for fiscal year 2007/2008 is the first report to be published as a result of the legislation. In subsequent years, the report will include comparative data for up to five fiscal years.

The 2007/2008 annual report exhibits data on injuries and illnesses (jointly referred to as incidents) reported by classified employees working in NYS Executive Branch agencies, incurred between April 1, 2007 and March 31, 2008.

There were 15,846 work-related incidents that resulted in a workers' compensation claim during fiscal 2007/2008. The overall workers' compensation incident rate was 9.6%. Approximately one-in-four incidents (4,271) resulted in lost time, accounting for 247,975 lost work days. Consistent with the statutory workers' compensation waiting period, lost work days were reported only for incidents with six or more work days lost. NYS paid \$18,690,687 for wage replacement benefits and \$19,690,167 for medical services related to these incidents.

The majority of incidents occurred due to three causes: overexertion/exertion (26.3%); falls (19.1%); and assaults (11.2%). The 2007/2008 incidents predominantly resulted in three injury types: soreness and pain - excluding the back (30.1%); sprains, strains and tears (15.8%); and bruises and contusions (8.5%). The most prevalent parts injured were: back (16.0%); knee (11.6%); and shoulder (8.2%).

Two job titles stood out with the highest number of incidents: Correction Officer (3,046); and Developmental Aide (1,899). Despite the high number of incidents, due to the large number of employees in these titles, they did not rank among the titles with the highest incident rates. Job titles with the highest incident rates were: Security Hospital Treatment Assistant (70.4%); Developmental Disabilities Secure Care Treatment Aide Trainee (39.5%); Security Hospital Senior Treatment Assistant (37.0%); and Developmental Disabilities Secure Care Treatment Aide 1 (36.6%).

The three agencies (with 500 or more employees) with the highest incident rates were: Office of Mental Retardation and Developmental Disabilities (16.6%); Office of Children and Family Services (14.7%); and Office of Mental Health (13.9%). Individual facilities with the highest incident rates were: Mid-Hudson Psychiatric Center (34.6%); Coxsackie Correctional Facility (25.7%); and Capital District DDSO (24.5%).

The Administrative Services Unit had the lowest incident rate (3.4%) and the Institutional Services Unit had the highest incident rate (22.1%). The incident rate for unrepresented employees was 5.5%.

Introduction

Background

Section 7 of the Civil Service Law was amended in Chapter 171 of the Laws of 2007 (Appendix A of this report) to require that the President of the Civil Service Commission prepare an annual report describing occupational injuries, illnesses and workers' compensation claims in Executive Branch state agencies. The report is required to be published by September thirtieth each year and include workers' compensation data based on the last completed fiscal year. In subsequent years, the report shall include comparative data for up to five fiscal years. A similar report was published by the Department of Civil Service from 1986 through 1992.

The report format follows the sections specified in Chapter 171 of the Laws of 2007. In Table 1, three of Chapter 171's sections (a, b, and c) were consolidated into one table. In Table 2, two of the sections (d and e) were also combined into one table. Additionally, recommendations required by section (j) of the legislation are general in nature due to lack of trend data, as this is the first year that the report is being issued after a sixteen year hiatus.

The Department of Civil Service, Employee Benefits Division, is responsible for overseeing the workers' compensation insurance policy between New York State and the State Insurance Fund (SIF). Part of this responsibility includes the reporting and monitoring of workers' compensation experience through the Accident Reporting System (ARS) and a summary of workers' compensation claims experience provided by the SIF. Workers' compensation data for this report are obtained from both ARS and SIF. Employee population data are obtained from the Department of Civil Service New York State Electronic Personnel System (NYSTEP).

Use of the two databases for workers' compensation data was necessitated by the reporting requirements specified in Chapter 171 of the Laws of 2007. Neither SIF or ARS database contained a complete picture of the information required for this report. As a result, there is a slight difference in the number of cases contained in each database: SIF cases equals 15,846 and ARS cases equals 15,405. The difference is due to cases being reported to SIF but not to ARS as a result of manual reporting for employees not eligible for an ARS report and the use of "small claims" by SIF in which an incident results in only one medical bill and no lost time and is not indexed by the Workers' Compensation Board. The small claim often does not result in an incident report being submitted through ARS.

Information in this report is presented in a summary manner at a very high level. New York State agency Human Resources, and Health and Safety, staff are encouraged to use the ARS reporting capabilities, which will allow for much greater detail of the information presented in this report, as well as many other workers' compensation incident details.

Explanatory Notes

The report **includes** selected Executive Branch agencies' Classified Service employees consistent with subdivision three of section two-a of the State Finance Law. The report *excludes* the Judicial Branch, Legislative Branch, and Unclassified Service and Authorities, as the Department of Civil Service does not maintain employee data on these groups.

Information in this report is based on New York State workers' compensation claims filed by the included employees. Although the reporting period is fiscal year 2007/2008 (April 1, 2007 through March 31, 2008), claims for FY 2007/2008 were reviewed until July 1, 2008 to allow for late reporting and for data to be captured for workers' compensation determinations that were made after the end of the fiscal year.

Incident data included in this report are for work related incidents, either injuries or occupational illnesses that were reported to the Workers' Compensation Board and the State Insurance Fund, as required by the New York State Workers' Compensation Law. The Law requires reporting of all incidents that result in either: one or more lost work day beyond the date of the incident; or medical treatment beyond first aid, or two or more first aid treatments. There are many incidents that do not reach the level of the reporting criteria under the Workers' Compensation Law.

Table 1: Workers' Compensation Incident RatesSelected New York State Agencies: Fiscal Year 2007/2008

Table 1 lists the selected Executive Branch New York State agencies' workers' compensation details specified in *Chapter 171* of the Laws of 2007, sections (*a*), (*b*), and (*c*). The information in Table 1 was provided by the New York State Insurance Fund from the claims experience included in the workers' compensation insurance policy for accidents occurring between April 1, 2007 and March 31, 2008 and reported through June 30, 2008.

There were a total of 15,846 workers' compensation incidents reported in FY 2007/2008. The average incident rate for the Executive Branch agencies was 9.6%.

Also reported in **Table 1** is the number of lost time incidents, lost time rate, lost time case rate, and lost work days. The lost time incidents are also included in the "*Incidents*" category but are distinguished by the criteria of having at least six or more work days lost. The lost time incidents do not include information on incidents having five days or less of lost time, which is the workers' compensation waiting period. In FY 2007/2008, there were 4,271 lost time incidents, with an average lost time incident rate of 2.6%. Approximately 27% of all workers' compensation incidents resulted in lost time. There were a total of 247,075 lost work days due to workers' compensation.

Table 2 lists the selected Executive Branch New York State agencies and contains the workers' compensation details specified in *Chapter 171* of the Laws of 2007, sections (*d*) and (*e*). The information in Table 2 was provided by the New York State Insurance Fund from the claims experience included in the workers' compensation insurance policy for incidents occurring between April 1, 2007 and March 31, 2008 and paid through June 30, 2008.

Under New York State Workers' Compensation Law, employees who are disabled due to a workers' compensation incident are entitled to a wage replacement for lost salary and medical benefits related to the incident. The wage component is equal to two-thirds of the employee's average weekly wage not to exceed a maximum established under the Workers' Compensation Law. During Fiscal year 2007/2008, the statutory maximum was \$400 from April 1 to June 30, and was raised to \$500 from July 1 to March 31. As of July 1, 2008, the maximum is \$550 per week. The data in Table 2 does not include supplemental wage replacement payment benefits as these amounts are paid by individual agencies and are not reflected in data maintained by the SIF. Under the medical component, all medical treatments, including doctor treatments, hospital or clinic charges, imaging services and diagnostic testing, prescription medication, and other related medical service, are paid in full based on a fee schedule contained in the Workers' Compensation Law.

All wage replacements and medical treatments are initially reviewed by the SIF and receive final review from the Workers' Compensation Board. Both the compensation costs and the medical costs are paid by the SIF under the provisions of the workers' compensation insurance policy between New York State and the SIF.

Tables 3A, 3B, 3C: Most Frequent Types of Injuries, AccidentCauses, and Body Parts Injured during Fiscal Year 2007/2008

In the next series of tables, details are provided on the most frequent types of injuries (Table 3A), accident causes (Table 3B), and body parts injured (Table 3C) as specified in *Chapter 171* of the Laws of 2007, section (*f*). The data in all three tables was derived from the Accident Reporting System (ARS) for all incidents that resulted in a workers' compensation claim during Fiscal Year 2007/2008.

The Occupational Injury and Illness Classification Manual issued by the U.S. Department of Labor, Bureau of Labor Statistics was used to capture the details on the types of injuries, accident causes, and body parts injured. This manual is very extensive and is the standard classification system used to classify occupational injuries and illnesses. Coding occupational injuries/illnesses is dependent upon the description provided by the reporter of the incident, the classification system being used, and the codes selected by the individual entering the information. As a result of this variability in coding, there is overlap noted in the descriptions of all three of the following tables. However, this overlap was maintained rather than consolidated in order to preserve the original integrity of the codes that were used and to account for small differences between these codes.

Table 3A, the Most Frequent Types of Injuries, includes injury types in which a minimum of fifteen of a specific category were reported. This inclusion criterion accounted for nearly 97% of all incidents. Four injury type categories accounted for nearly 63% of all incidents: soreness, pain, excluding the back (30.1%); sprains, strains, tears (15.8%); bruises, contusions (8.5%); and back pain, hurt back (8.4%).

The most frequent incident causes are detailed in **Table 3B**. Twenty incidents per cause were used as a minimum criterion to be included in this table, which accounted for nearly 96% of all incidents. The two most frequent incident causes were a fall to the floor, walkway, or other surface (8.2%) and bodily reaction and exertion (7.5%).

The most frequent body parts injured are listed in **Table 3C**. Twenty incidents per body part were used as a minimum criterion to be included in this table, which accounts for nearly 99% of all incidents. Three body parts represented over one-third of the body parts injured: the back, including spine, and spinal cord (13.9%); knee(s) (11.6%); and the shoulder, including clavicle and scapula (8.2%).

Table 6 contains selected Executive Branch New York State negotiating units workers' compensation details specified in *Chapter 171* of the Laws of 2007, section (*i*). Summary of Findings and Recommendations

Findings

- There were 15,846 work related injuries or illnesses that resulted in a workers' compensation claim (Table 1, page 15).
- The overall workers' compensation incident rate was 9.6% (Table 1, page 15).
- Approximately one in four incidents resulted in lost time. There were 4,271 lost time incidents resulting in 247,975 lost work days (Table 1, page 15).
- Workers' compensation costs were \$18,690,687 for compensation (wage replacement) and \$19,690,167 for medical services (Table 2, page 22).
- The top three injury types were: soreness and pain excluding the back (30.1%); sprains, strains and tears (15.8%); and bruises and contusions (8.5%) (Table 3A, page 24).
- The top three combined incident causes were: overexertion/exertion (26.3%); falls (19.1%); and assaults (11.2%) (Table 3B, page 25).
- The top three body parts injured were: back (16.0%); knee (11.6%); and shoulder (8.2%) (Table 3C, page 27).
- The top three job titles with the highest number of incidents were: Correction Officer (3,046); Developmental Aide (1,899); and Mental Health Therapy Aide (637). Job titles with the highest incident rates were: Security Hospital Treatment Assistant (70.4%); Developmental Disabilities Secure Care Treatment Aide Trainee (39.5%); and Security Hospital Senior Treatment Assistant (37.0%) (Table 4, page 30).
- The top three agencies (with 500 or more employees) with the highest incident rates were: Office of Mental Retardation and Developmental Disabilities (16.6%); Office of Children and Family Services (14.7%); and Office of Mental Health (13.9%). Individual facilities (with 500 or more employees) with the highest incident rates were: Mid-Hudson Psychiatric Center (34.6%); Coxsackie Correctional Facility (25.7%); and Capital District DDSO (24.5%) (Table 5, page 33).
- The Administrative Services Unit had the lowest incident rate (3.4%) and the Institutional Services Unit had the highest incident rate (22.1%). The incident rate for unrepresented employees was 5.5%. (Table 6, page 37).

Recommendations

The following recommendations regarding the prevention of injury and illnesses and the reduction of costs due to these cases were prepared in consultation with the Workers' Compensation Board and the New York State Insurance Fund. Year-to-year comparative data and analysis will not be available until the 2008-2009 report is published on September 30, 2009.

- The data presented in the 2007-2008 annual report is on a summary basis. Detailed information and reporting is available to each agency through the Accident Reporting System, including the physical location where incidents occurred, job titles specific to an agency and detailed case records which describe how incidents occurred. Individual agencies are encouraged to analyze their workers' compensation experience using the tools available in the Accident Reporting System and share this data with their health and safety committee to help prevent future injury and illness.
- In October, 2008, the New York State Insurance Fund (SIF) is rolling out a pharmacy network to allow injured workers' compensation claimants to obtain prescribed medication (with no out of pocket expense) at a participating pharmacy, immediately after their hospital or doctor visit. The voluntary use of a participating pharmacy will reduce workers' compensation medical expenses due to negotiated discounts with the pharmacies. We recommend that individual agency personnel offices determine steps that they can take to ensure that injured workers are aware of and utilize the SIF pharmacy network.
- The New York State Insurance Fund recommended that the Department of Civil Service work closely with SIF to make best use of their knowledge and resources in order to reduce the State's workers' compensation costs.
- The Workers' Compensation Board recommended that the Department of Civil Service and the Workers' Compensation Board collaborate to develop a data reporting structure that would allow improved comparability of workers' compensation claims data maintained by each.

CHAPTER 171

AN ACT to amend the civil service law, in relation to requiring annual reports about employee accident rates and costs in state agencies

Became a law July 3, 2007, with the approval of the Governor. Passed by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7 of the civil service law is amended by adding a new subdivision 6 to read as follows:

6. The president of the commission shall prepare an annual report describing occupational injuries, illnesses, and workers' compensation experience for all state agencies as defined by subdivision three of section two-a of the state finance law. Such report shall be published no later than September thirtieth of each year, beginning in two thousand eight, and shall report information on the basis of the last completed state fiscal year. In subsequent years, the report shall include comparative data for up to five prior fiscal years if such data is available. The report shall be delivered to the governor, the legislature and to any labor organization that represents state agency employees and shall be available to the public. The contents of the report shall include the following information for each state agency, broken down by institutions and facilities as was done in the report previously published by the department entitled "Occupational Accidents and Workers' Compensation Experience for NYS Government Employees" published from nineteen hundred eighty-seven to nineteen hundred ninety-two:

(a) the total number of employees, the number of work-related accidents and the rate of work-related injuries and illnesses;

(b) the number of lost work time injuries and illnesses and the rate of lost work time cases;

(c) the number of days of lost work time and the number and rate of lost full time employees;

(d) the cost to the state of lost work time due to work-related cases; (e) the cost to the state of medical expenses due to work-related injuries and illnesses;

(f) a description of the types of injuries, the number of injuries and illnesses of each type and the most common causes of those cases, and the body part injured;

(g) a list of the job titles with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(h) a list of the state agencies with work-related injury and illness rates that are more than twenty-five percent above the average for all state agencies;

(i) work-related injury and illness rates for all state agencies by collective bargaining units; and

(j) a summary of findings and recommendations prepared in consultation with the workers' compensation board and the state insurance fund for state agencies regarding the prevention of injury and illnesses and the reduction of costs due to these cases.

§ 2. This act shall take effect immediately.
