Northeast Health District - 10 counties

- 5 urban and 5 rural counties
- Largest diverse population is Latino
- 30% of residents in two most populated areas
- Largest city, Allentown, 60% of schoolage children live below federal poverty level

Purpose

- Needs assessments in FY08 and FY09 focused on program standardization, implementation, and continuity
- Program Challenges for FY 2010
 - Define program gaps in each area of work (prevention, cessation, disparate populations)
 - Identify strategies for specific populations (pregnant smokers, young adults)
 - Training and education of existing and new staff

Focus

- Examine current programming and prevention and cessation monitoring evaluation data
- Training and education of healthcare providers in chronic disease integration and patient referral to tobacco services
- Determine future strategy and program direction

FY 2010 Priorities

- Young adults not in college
- Low-income pregnant girls and women
- Latino/Latina youth and adults
- LGBT teens and adults
- Tobacco free policies parks and recreation
- Alignment with chronic disease programs
- Over sampling FY 2009 BRFSS in Northeast District: Urban vs. Rural

Primary Data

- Ongoing staff strategy discussions Re: Data Collection and Analysis
- College Tobacco Free Campus Survey
 - Results: all 23 colleges have total bans inside and some outside
 - Strategy: train wellness staff on campus to provide cessation
- Hospital Tobacco Free Campus Survey:
 - Results: all but 4 of the 18 hospitals have tobacco free campuses
- Young adult conference findings
 - Results: social marketing instead of mass media

Secondary Data


- Pregnant smokers: 2 epidemiologists examined 2 different datasets
 - Results: Pregnant smokers primarily quit in first trimester, those who continue into last trimester have multiple life issues and account for 3,000 people in a 1.5 million population area
 - Strategy: intervene with yound adults prior to pregnancy through social marketing
